Troup Road is an unpaved dedicated county Right-of-way on the ocean side, in Key Largo, . It runs from the Highway east to just past the Childrens Memorial Tree Garden. Beyond that point the county abandoned the ROW. On the north side of this short road is Arby's whose entrance is on the northside not facing Troup Road. East of them is the backside of the Publix store located in the Tradewinds Shopping Center who's entrance also faces north, into the shopping center. On the South side of Troup Road is Friendship Park. A county Park whose entrance faces, south towards Hibiscus Lane to the South.

The only entity that faces or can face on Troup Road is the Childrens Memorial Tree Garden hence the request for a name change to "Tree Garden Way". Thank You;
