A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MONROE COUNTY, FLORIDA ADOPTING THE FINAL RESIDENTIAL SOLID WASTE COLLECTION, DISPOSAL AND RECYCLING RATES FOR THE FISCAL YEAR 2007 - 2008

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MONROE COUNTY, FLORIDA, as follows:

Section 1. The Board hereby adopts the following final rates for Collection of Residential Solid Waste:

- 1. For each single family home - \$117.00 per annum;
- 2. For each mobile home - \$117.00 per annum;
- 3. For each multi-family unit - \$117.00 per annum.

Section 2. The Board hereby adopts the following final rates for Disposal of Residential Solid Waste:

- 1. For each single family home - \$134.00 per annum;
- 2. For each mobile home - \$134.00 per annum;
- 3. For each multi-family unit - \$134.00 per annum.

Section 3. The Board hereby adopts the following final rates for Recycling of Residential Solid Waste:

- 1. For each single family home - \$41.00 per annum;
- 2. For each mobile home - \$41.00 per annum;
- 3. For each multi-family unit - \$41.00 per annum.

Section 4. The total final rates for FY 2007/2008 are:

- 1. For each single family home - \$292.00 per annum;
- 2. For each mobile home - \$292.00 per annum;
- 3. For each multi-family unit - \$292.00 per annum
