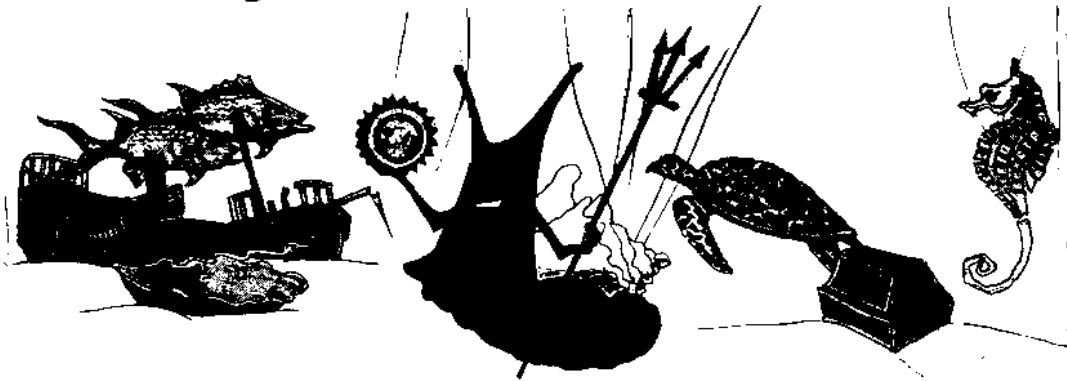

TWINS AND MULTIPLES DAY October 19, 2007
