

RESOLUTION NO. – 2006

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MONROE COUNTY, FLORIDA, AUTHORIZING CAROL A. COBB TO EXECUTE, ON BEHALF OF MONROE COUNTY, LIENS AND SATISFACTIONS OF LIEN RELATING TO THE SPECIAL ASSESSMENT FOR SOLID WASTE COLLECTION AND DISPOSAL.

WHEREAS, pursuant to Ordinance No. 10-1977, it will become necessary from time-to-time for Monroe County to execute Liens and Satisfactions of Lien relating to delinquent payments of the Annual and/or Semi-Annual Special Assessment for Solid Waste Collection and Disposal, and

WHEAREAS, it is proper that a person and/or persons be vested with the authority to execute Liens and Satisfactions of Lien, now, therefore,

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MONROE COUNTY, FLORIDA:

Section 1. That Carol A. Cobb be, and hereby is, authorized to sign, execute and file in behalf of the Board of County Commissioners of Monroe County, Florida, Liens and Satisfactions of Lien as may from time-to-time be necessary pursuant to Monroe County Ordinance No. 10-1977, as amended, with regard to the payment of the delinquent Annual Special Assessment for Solid Waste Collection and Disposal.

Section 2. Liens and Satisfactions of Lien signed by Carol A. Cobb shall be entitled to full force and effect as though granted or issued by the Board of County Commissioners.

Section 3. Provided, however, that Carol A. Cobb shall have no power or authority to compromise any lien for less than the full amount owed and she shall neither issue nor grant any Satisfaction for less than the full amount due.

PASSED AND ADOPTED by the Board of County Commissioners of Monroe County, Florida, at a regular meeting of said Board held on the 15th day of February, 2006.


